

### What is an AFD?

A fully trained assistance dog from an assistance dog school that is accredited through Assistance Dogs International (ADI).

#### These dogs are:

- Trained from birth to 2 2.5 years of age.
- Exposed to a wide variety of people, places and things.
- Temperament tested.
- Successfully complete ADI's "Public Access Test" at placement and throughout their life.
- Very low energy, stable and calm temperament, best practice for ppl who have experienced trauma.
- Have exceptional obedience and behaviours conducive to being in a forensic interview or courtroom.




### What is the International Best Practice?

An International Best Practice has been established for dogs working in our industry. It is:

- 1. The Facility Dog should be a graduate from an assistance dog organization that is a member of Assistance Dogs International.
- 2. The Facility Dog handler is a professional with training and experience working in the legal system (such as a victim advocate, investigator or forensic interviewer). The handler should have experience in trauma informed practice.

### Benefits of AFD Intervention





- Defuse intense emotions and anxiety.
- Provide an outlet for cathartic touch.
- Lower blood pressure and heartrate.
- Assist people struggling to communicate.
- Normalize traumatic situations.
- Draw out healthy emotions.
- Act as a goodwill ambassador for agency.

# Trauma, AFD's and the Oxytocin Effect

- Trauma and activation of the Sympathetic Nervous System.
- Cortisol and cognitive impacts.
- Dog intervention & oxcytocin.


### Forensic Interviews




- Reduce anxiety.
- Mitigate the impact of revisiting the trauma.
- Assists with disclosures.
- Can assist in keeping child in the room when they wish to depart.
- Child can look at the dog if it is more comfortable than making eye contact with the investigator.
- Dogs are NEVER to be used as an incentive to come to an interview but the knowledge that the dog was there the last time may be an incentive for re-interviews.
- Tips not an incentive, pre-interview meetn-greets are imperative to determine child's comfort and ensure child is not negatively distracted.

### Forensic Examinations

- Dog DNA and human DNA are distinct, thus no cross-contamination.
- Incentive to complete exam, provide physical comfort through touch during the exam.
- Calm, low energy of dog is soothing.



### Court Orientation



- Incentive to attend orientation.
- Opportunity to determine if utilizing the dog for court accompaniment would be appropriate.
- If emotions arise the AFD can assist in mitigating the impact of the immediacy of court/testimony.




### Hospital Visitation

- Assist with fears associated to medical intervention.
- Provide physical comfort.
- Lower BP and HR.

# Court Accompaniment

#### Steps & Considerations:

- AFD resume.
- Client/AFD pre-court meeting.
- Testimonial aid application (handler may have to testify to application).
- Handler to be deemed "support person" and in close proximity to dog.
- Dogs usually on floor on a mat or "target".
- Dogs must have perfect behaviour and not disrupt the proceedings.
- Seek comments "on the record" about the dogs behaviour.
